Payment: MCX-USA accepts Visa & MasterCard, wire transfers, COD, or a company check. Any check that is returned NSF will be charged a \$25 processing fee. All prices are quoted with a 3% discount for cash.

Shipping: MCX-USA will ship via UPS or FedEx ground unless specified otherwise. MCX-USA is not liable for any damages during shipping. All goods are carefully packed and are in good condition when shipped. Lost, damaged, or stolen claims must be made with MCX-USA. MCX-USA assumes no responsibility beyond delivery to the carrier and is not responsible for loss, damage, or delay occurring thereafter.

Returns: Authorization for returns are required to send back any and all merchandise to MCX-USA. Returns will be charged a 10% restocking fee.

Warranty: Items sold by MCX-USA may void the manufacturers warranty and MCX-USA only warranties products to be free of manufacturer’s defects at time of delivery, but makes no other warranty claims. If any items sold are thought to be defective MCX-USA needs to be notified within 5 business days. A return authorization must be given from MCX-USA before any returns will be accepted.
